Programme of Audits 2013

Since the entry into force of Reg. (EC) No 882/2004 (on official controls), the FVO assesses Member States' Annual Reports on the implementation of their Multi-Annual National Control Plans and provides feedback to Member States, aimed at improving the quality of these reports. A new series of Systems Audits is being introduced with the purpose of focusing on selected horizontal elements of Reg. (EC) No 882/2004, e.g. verification procedures and enforcement, to identify good practice as well as difficulties encountered with implementation. Furthermore, following on from the lessons learnt from the *E. coli* outbreak in Germany in 2011, the FVO will start a new series on emergency preparedness in 2013. Amongst others, it will address contingency planning in the feed and food chain, co-ordination and co-operation between different authorities including public health authorities, traceability of feed and food, alert systems and recall procedures.
